SHARING THE HARVEST

Meeting on Community Supported Agriculture, Minehead July 1st 2010

"CSA is a partnership between farmers and consumers where the responsibilities and rewards of farming are shared."

There has been interest in setting up a local CSA scheme for some time. Forum 21 and Transition Minehead and Alcombe organised this meeting to assess the strength of local interest and to inform people about the options.

After a slide presentation provided by the Soil Association, we had a very stimulating talk from Ed Hamer who was instrumental in starting the successful CSA scheme on Dartmoor. Their scheme is organised like many others: members are recruited, land is rented and workers employed to grow the produce. An initial grant made this possible.

This is not the only way to organise a CSA. Twenty people registered their interest after the meeting, and the project is being taken further by Carol Stone, Food for Living co-ordinator for West Somerset. What form an eventual CSA project will take will depend on local circumstances and local people.

More on the Feed-in Tariff (FIT)

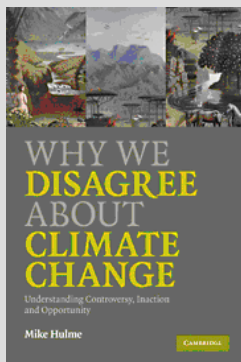
Installers are busy fitting photovoltaic panels on local homes. Forum 21 member Charles Birch says it's a no-brainer: produce your own electricity and be paid for it. But that's OK for those people who can afford the upfront cost of around £10,00. What about those who can't? People who have trouble paying their expensive fuel bills aren't likely to have this sort of amount available, and yet they are the very people who could benefit most from some the scheme. Even more unfair is the fact that the cost of the FIT will be borne by everyone through their electricity bills, while only the fortunate will reap the benefit.

So it's not surprising that some commercial companies, including British Gas, have come up with schemes to help people afford it. A typical scheme offers the householder free installation of the PV panels, thus saving the upfront cost. The company makes its money by taking the income from the FIT: currently 41.3p per kilowatt generated. The householder gets the free electricity, saving perhaps a third of their bill. A reputable company will cover maintenance and insurance costs. And no problem if you move - the scheme transfers to the next householder.

Sounds good. So what's the catch? Well, it's been estimated that the company could be earning £35,000 over the 25 years of the scheme, an easy and guaranteed income. The householder will be getting much less. One financial journalist has estimated that if the householder took out a loan to pay for the installation themselves, even at an interest rate of 12% (far higher than it is now), they would be paying a total of £20,000 over the period of the loan, and gain the £35,000 from the FIT. So, much better off. Another no-brainer? Probably yes. But not so good if you move house after a few years.

The previous government was toying with making low interest loans for renewables that would act like a mortgage, to be transferred to a new owner. This might still happen with the change of government but is by no means certain. Meanwhile, there is a low interest (3%) loan scheme operated in West Somerset by Wessex Home improvement Loans. Available to home owners on low incomes, loan can be used for home maintenance and improvements, including renewables. “Why we disagree about climate change: Understanding Controversy, Inaction and opportunity” by Mike Hulme, Cambridge University Press, ISBN 978-0-521-72732-7

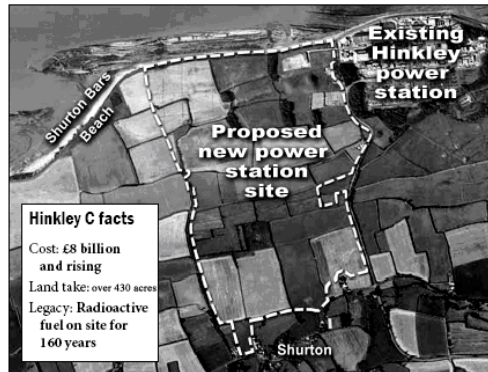

Renewables Help Keep the Lights On



Renewable energy continues to expand in Britain, with the government's target for about a third of our electricity to come from green sources by 2010. Wind power registered a record output at the beginning of September, meeting 10% of the country's electricity supply, according to the National Grid. EDF Revises "Hinkley C" Plans – Make Your Comment by 4th October

EDF (Electricite de France) has published revised (Stage 2) plans for the construction of its proposed new nuclear power station at Hinkley Point. These include a shifting round of where the accommodation hostels will be located and concentrating more of the park and ride and freight consolidation facilities near the M5 motorway. None of these changes have fundamentally altered the continued opposition of local communities and both local authorities affected (West Somerset and Sedgemoor) to many of EDF's proposals, however. Apart from the nuclear element these plans will still result in massive disruption to both traffic and the daily life of local people – and without any serious compensation.

If you want to comment on the EDF Stage 2 proposals, go to www.edfconsultation.info but remember that you can submit other points apart from answering the very limited questionnaire which the website offers. The deadline is 4th October. Forum 21 will be submitting its own comments to EDF, emphasising the point that the negative effects of a new nuclear power station, including at least 160 years' storage of radioactive waste, far outweigh any potential benefits to West Somerset.

"Preliminary Works" – EDF Jumps The Gun

Developer EDF is proposing to completely destroy a large area of the West Somerset coastal countryside in advance of obtaining full planning permission for its proposed new nuclear plants. Called "Preliminary Works", the application to West Somerset Council, expected soon, will mean:

- Removal of the majority of trees and hedges, including ancient woodlands
- Blocking off all badger setts (already agreed)
- Closure of existing footpaths and bridlepaths, including the coast path
- Security fencing round an area of more than 400 acres
- Stripping topsoil and vegetation to make terraced area for the proposed nuclear reactors
- New roads across the site
- Underground streams re-routed
- The excavation of more than 3.2 million cubic metres of soil, sub-soil and rocks. **This is more than has been excavated to prepare the site for the 2012 London Olympic Games.**
- Construction of new sea wall along the coast and a jetty out into the sea

EDF says it will "restore" the site to its original state if it does not receive planning permission for the power station. This is impossible – you cannot recreate a landscape that has taken hundreds of years to mature. *See photos on the Forum 21 website news page.* The coastline bordering the Hinkley C site is part of the Bridgwater Bay Site of Special Scientific Interest (SSSI). Bridgwater Bay's shallow waters and mudflats are a sanctuary for thousands of waders, ducks and other sea birds, especially in winter.
